#### **Matters Arising From Action Points**

#### **Fire Safety Notices**

- It was announced that LB has had to resign from the Committee, as she and her husband are moving back into Edinburgh
- All agreed that that this was a great shame, as it had been good to have a fresh point of view at meetings as well as extra help at events
- The loss of two members in such quick succession makes recruitment an ever more pressing issues
- · It was decided to institute a poster and website "campaign" highlighting all the positive aspects of our work
- KM agreed to take the lead, and will e-mail drafts around as soon as possible
