Matters Arising from Actions Points

- As the weeds to the rear of the Hall are now in "full bloom," it was agreed that it was too late to effectively remove them and landscape the area this year
- As such, the issue will be readdressed in the Spring and a local gardener/handyman be asked to come and quote for the work

Chair Feet

- All the Hall's upholstered chairs were checked to ensure they had four proper plastic feet
- Two chairs were found wanting, and will have new feet fitted as soon as possible

Building Works

- At the last meeting, it was agreed that LY would ask her brother, a glazer, to provide an alternative quote for renewing the Hall's leaded windows
- KM agreed to speak to LY and see if there had been any progress in the last couple of months, and circulate any
 information around the committee by email

- This was a well supported event, raising £430 for the Hall and another £350 was donated to the DEC Nepal Appeal

Future Events

- There was some discussion as to what might be organised in the coming months, namely something at Christmas, a Hogmanay ceilidh and/or a Burns Supper
- A formal Christmas Fair was discounted as there are many similar events in the county, but there was some suggestion that the turning on of the Christmas tree lights could be celebrated in some way

 agreed to post a notice on the website saying that the Hall would be available on 31st December
